Executive Summary: On November 28, 2023, a presentation by Partnership Health Plan Regional Director Lynn Scuri included highlights of the Partnership Health Plan expansion and a request to amend ordinance to reflect a change in their membership by-laws.

The amendment(s) include the following changes in bolded italics:

"Sec. 2-195. Membership of Commission.

Commission representation shall be based on the number of Medi-Cal beneficiaries enrolled in the HealthPlan in that county as follows: one commissioner per zero to forty-five thousand beneficiaries; two commissioners per forty-five thousand and one to sixty thousand beneficiaries; three commissioners per more than sixty thousand and one beneficiaries
