## **Executive Summary:**

Pursuant to your Board identifying "Building Sustainable Communities Through Housing and Long-Term Planning" among your Recovery and Revitalization Priorities, the American Rescue Plan Act-Coronavirus State and Local Fiscal Recovery Funds (ARPA-SLFRF) Committee recommended dedication of up to \$300,000 for completion of a comprehensive Housing Action and Implementation Plan.

Pursuant to County Policy, an open and competitive Consultant Selection Process was undertaken. Five qualified firms were directly invited to submit a Proposal for Housing Action and Implementation Plan Consulting Services. Three Proposals were received by the deadline of February 15, 2024.

The Consultant Selection Panel convened on Monday, March 4, 2024. PlaceWorks emerged as the
