**Subject:** Adopt Proclamation Designating the Month of May 2024, As CalFresh Awareness Month

#### Executive Summary:

**WHEREAS,** CalFresh is a monthly benefit for food purchases that helps low-income residents gain access to healthy foods and participation can play a crucial role in improving the health and status of vulnerable populations; and

**WHEREAS,** every \$1 in CalFresh generates \$1.79 in local economic activity; and

**WHEREAS,** 17,169 individuals in Lake County are currently receiving CalFresh benefits totaling \$3.08 million per month, \$32.73 million in benefits over the course of the last year; and

**WHEREAS,** the County of Lake, Department of Social Services, recognizes the need to reduce hunger by increasing access to and participation in food assistance benefits, particularly for elderly, disabled, families and children, and is committed to an outreach and public awareness campaign that promotes equity and inclusion in access, and to increasing awareness of potentially eligible Lake County residents about the benefits of CalFresh.

**NOW, THEREFORE, BE IT PROCLAIMED** that the Board of Supervisors of the County of Lake does hereby designate the month of May, 2024 as CalFresh Awareness Month.
