Subject: Approve Task Order No.4 for On-Call Construction Management Services, with MGE Engineering, Inc. for HBP-Funded Bridge Project BRLO-5914(111) Bartlett Springs Rd over Bartlett Creek in Lake County, CA in the Amount of \$305,675.39, and Authorize the Chair to Sign.

Executive Summary:

On July 14, 2020, the Board of Supervisors approved a Master Agreement between the County of Lake and MGE Engineering, Inc. for On-Call Construction Management Services for HBP-Funded Bridge Projects in the amount of \$2,500,000. Each individual project will have a Task Order No. assigned to it. This is the fourth Task Order for the referenced Master Agreement.

TASK ORDER NO. 4

Task Order No. 4 is to provide construction management services for the Bartlett Springs Rd over Bartlett Creek Bridge Replacement Project, Federal Project No. BRLO-5914(111) Bartlett Springs Rd over Bartlett Creek. The total for Task Order No. 4 is \$305,675.39, see Exhibit "A" for details.

The remaining balance on the Master Agreement is \$1,487,515.32

The cost of services to be rendered under this Task Order will be funded through the federal highway bridge program and state toll credits, as appropriate.
