## **Executive Summary:**

The National Association of Pretrial Service Agencies Annual Conference and Training Institute is being held in New Orleans, Louisiana September 8<sup>th</sup> through 11<sup>th</sup>, 2024. Officers Lara and Perez handle all pretrial cases for the Probation Department and this conference is the premier training for pretrial services. Because of the distance of the conference, the officers may need to travel the day before and the day after depending on the timing of the classes.

The Probation Pretrial Unit is the newest unit in the Department and there is currently no other local training of this caliber.
