After review, the Department's fiscal team has determined that an increase of \$1,200 is needed to close out the fiscal year of services. Alameda County After Hours Crisis Support bills based on call volume. We are currently evaluating whether we need to continue to utilize this contracted provider now that we have 24/7 mobile crisis dispatch who can take calls after hours. We are working on exploring a phone tree option, as well.
