WHEREAS, the richly diverse cultures of Lake County's seven Tribal Nations, Middletown Rancheria of Pomo Indians of California, Koi Nation of Northern California, Big Valley Band of Pomo Indians, Scotts Valley Band of Pomo Indians, Habematolel Pomo of Upper Lake, Robinson Rancheria of Pomo Indians of California and Elem Indian Colony greatly enhance every facet of life in our communities; and

WHEREAS, by bringing people from different backgrounds and experiences together, diversity fosters creativity and innovation, leading to new ideas, perspectives, and solutions to problems; and

WHEREAS, celebrating diversity enhances personal growth and encourages greater empathy and compassion for others.
