#### Executive Summary:

On Thursday, April 9, thousands County residents and otherwise interested people gathered online for District 5 Supervisor, Rob Brown's, first Virtual COVID-19 Town Hall for Business Owners. Social Media posts and other web-based engagement, including video of this event, reached approximately 10,000 people, including 4,400+ views of the English language video and 1,700+ views of the Spanish language simulcast on Facebook.

CDS is a partner of Lake County Economic Development Corporation (LCEDC), a collaborative effort of the County, Cities of Lakeport and Clearlake and other community organizations, and is a NorCal Small Business Development Center Affiliate. They have been providing a variety of supports to local businesses for decades, including facilitating access to State and Federal funding opportunities; CDS can be reached at 707-279-1540.

Melissa Fulton, Chief Executive Officer of the Lake County Chamber of Commerce will additionally present the results of a survey, documents impacts to local businesses of COVID-19.
