Executive Summary: Attached, for your approval, is the Agreement between the County of Lake and BHC Sierra Vista Hospital for Acute Inpatient Psychiatric Hospital Services and Professional Services Associated with Acute Inpatient Psychiatric Hospitalizations for Fiscal Year 2019-20.

Lake County Behavioral Health Services (LCBHS) is mandated to pay acute inpatient psychiatric hospital services for Lake County clients. BHC Sierra Vista Hospital is an acute psychiatric hospital providing an acute hospital level of care. This facility has been useful for the hospitalization of Lake County clients when required.

As LCBHS has placed Lake County clients at this facility in the past and has developed a working relationship, LCBH is
