## **Executive Summary:**

The County of Lake, Department of Health Services, Public Health Division was recently awarded additional funding from California Department of Public Health for the COVID-19 Crisis Response. This award will be distributed in a lump sum for a total of \$159,359.

California Department of Public Health has provided funding to Lake County to enable COVID-19 Crisis Response. Crisis response allocation is detailed in the attached Resolution for your approval, and will include:

- Additional salary, overtime, FICA, and PERS costs
- COVID-19 special department expenses.
