Executive Summary: (include fiscal and staffing impact narrative):

Our consultant Paragon Partners, Ltd. has reached an agreement for the purchase of property known as Assessor's Parcel Number 004-013-190 and 004-014-130 owned by Steven Jones. The purchase of this property will be a step closer toward the development of the Middle Creek Flood Damage Reduction and Ecosystem Restoration Project.

The purchase of this property is being completed using Grant funds provided by the State of California, Department of Water Resources, and the Flood Corridor Program following the provisions required by the Uniform Relocation Assistance and Real Properties Acquisition Policies Act of 1970. The appraisal was prepared by a third party hired by our relocation consultant, Paragon Partners, Ltd. with review and approval by the State of California, Department of Water Resources Real Estate

Division. The Purchase Agreement is attached for your review and approval.
