Executive Summary: (include fiscal and staffing impact narrative):

On March 18, 2021, the California Department of Transportation (Caltrans) notified the County of the opportunity to participate in the Optional RSTP Federal Exchange and State Match Program for FFY 2020/2021. The exchange amount is based on the County's estimated FFY 2021 apportionments.

On an annual basis, the County has exchanged the Federal RSTP dollars for unrestricted State dollars which provide greater flexibility on the type and location of projects to be funded. The County continues to meet the criteria to exchange the 2020/2021 apportionments.
