Executive Summary: Attached for your review is the Resolution and Standard Agreement between CADTP and LCBHS for development of an early recognition and intervention OUD/PolySUD pilot program to benefit DUI program participants, and supporting the creation of linkages to resources and referral options to MAT to reduce opioid overdoses, opioid-related traffic fatalities, curb recidivism, and provide other treatment options and referrals. This Agreement provides funds up to Seventy Four Thousand Nine Hundred Dollars (\$74,900.00). It also authorizes the SUD Administrator of Lake County Behavioral Health Services, as the lead agency for the Lake County Continuum of Care, to sign and execute the standard agreement.
