Subject: Redistricting Public Hearing #1 - Introduction to the Redistricting Process

Executive Summary:

As your Board is aware, Census data is collected every ten years, and in the year following, Counties are responsible to undertake "Redistricting," to ensure that Supervisorial Districts are essentially equivalent, in terms of population.

Pursuant to California Elections Code Section 21507.1, your Board is required to hold a series of four Public Hearings. On August 11, you adopted the following schedule for these hearings:

Tuesday, August 31: Public Hearing #1 - **Intro to the Process**Special Board Meeting, Timed Item for 10am

Saturday, October 2: Public Hearing #2 - Communities of Interest

Special Board Meeting, at 10am, solely to conduct this Redistricting Public Hearing

Tuesday, November 2: Public Hearing #3 - **Draft Maps Presented** *Regular Board Meeting*, Timed Item for 6pm

Tuesday November 30: Public Hearing #4 - Final Approval of Boundaries/Maps

Draft maps will not be available until County-level 2020 U.S. Census data is released by the State of California; this is expected to occur in early-mid September.
