**Executive Summary:** The Sheriff's Department is requesting your Boards' approval to purchase seven (7) 2022 Ford Explorer Police Pursuit vehicles. These vehicles will be marked patrol units and will be used in the enforcement division.

A request for sealed bid was issued on July 8, 2021 and bids were received from the following dealers: Napa Ford Lincoln, Downtown Ford, Hansel Auto and Redwood Ford. This bid was also posted on both the County and Sheriff websites.

Redwood Ford - Bid was not received prior to the bid deadline  
Downtown Ford - \$43,061.89  
Hansel Auto - Bid was not for the requested model year  
Napa Ford Lincoln - \$40,780.69
