DESIGNATING THE WEEK OF MAY 1 - 7, 2022 NATIONAL SMALL BUSINESS WEEK

WHEREAS, America's progress has been driven by pioneers who think big, take risks and work hard; and

WHEREAS, from the storefront shops that anchor our downtown areas to the high-tech startups that keep America on the cutting edge, small businesses are the backbone of our economy and the cornerstone of our nation's promise; and

WHEREAS, small business owners and downtown businesses have energy and a passion for what they do, when we support small business, jobs are created and local communities preserve their unique

culture; and

WHEREAS, because this country's 30 million small businesses create nearly two out of three new jobs in our economy, we cannot resolve to create jobs and spur economic growth without discussing ways to support entrepreneurs; and

WHEREAS, when the COVID-19 pandemic struck, it posed a historic challenge to small businesses from big cities, small towns, rural enclaves, and Tribal communities; small business owners and workers demonstrated remarkable courage and resilience; and
