Executive Summary:

Lake County Behavioral Health Services has been working with Resource Development Associates for many years to support Mental Health Services Act (MHSA) evaluation and planning and activities and currently has a two year contract to support these activities, as well as evaluation for the Lake County Continuum of Care's Whole Person Care Grant Project. This Amendment reflects a revised Scope of Work and increases the total amount payable under the Agreement by \$113,350.00 for a new amount of \$268,060.00.
