### Executive Summary:

Lake County has contracted with the Tri-County Regional Juvenile Rehabilitation Facility for youth housing since 2015. This facility offers a "Youth Camp" and is an alternative to traditional hall type placement. We currently have no juveniles in this facility; however, our Superior Court does occasionally order placement so maintaining a contract for that possibility is necessary.
