I would like to ask the Board to adopt the attached resolution approving the Industrial Hemp resolution agreement with the California Department of Food and Agriculture. This agreement reimburses the County for registering hemp growers and seed breeders, enforcing all laws and regulations, public outreach, reimbursement for mileage and supplies pertaining to industrial hemp. The agreement would reimburse the County up to \$23,781.69 for the activities listed above. This agreement term is from July 1, 2022 through June 30, 2024.
