Executive Summary:

The original Agreement's contract maximum was \$25,000.00, below the threshold for the competitive bidding process. Due to unforeseen circumstances and a need to support the robust grant and grant reporting activities of the Lake County Continuum of Care, additional services were required in the amount of \$5,723.00.

In the future, Lake County Behavioral Health Services, administrative entity for the Lake County Continuum of Care, will go out to bid for such services if it is determined the need for services will exceed the threshold contract amount of \$25,000.00.
